SUBJECT: Revised CMAQ/STP Programming for Allen Creek Road Improvements Project

The City of Grants Pass requested revisions to the Congestion Mitigation Air Quality (CMAQ) Program and Surface Transportation Program (STP) funding amounts for the Allen Creek Road Improvements Project. The City proposes to increase the CMAQ dollars applied to the project by \$1,287,571 and decrease the STP dollars by \$3,069. The City worked with ODOT to develop the revised CMAQ and STP amounts.

It is important to note that the MRMPO's CMAQ dollars may only be applied to projects that lie within the Grants Pass Air Quality Maintenance Area (Grants Pass UGB area), and projects must meet CMAQ eligibility requirements. A surplus of CMAQ dollars currently exists with an available balance through FFY 2018 of \$4,608,760.

The TAC recommends the Policy Committee approve the revised funding for this project which is included in the draft RTP project list (Agenda Item #4). It was suggested at the TAC meeting that the MPO consider developing a policy on allocating unused/surplus CMAQ and STP funds. Staff will prepare a draft policy to present to the TAC at their June meeting. Staff will request a TAC recommendation to the Policy Committee on the proposed policy.
