Description: Increase PE phase by \$1,325,000 with Federal (CMAQ) funds with local match from the construction phase, replace Federal funds with local overmatch from the City of Grants Pass.

#### DESCRIBE

 $\boldsymbol{C}$ This is an ARTS project that addresses intersection safety issues at two separate locations on OR234 (Hwy #271) and one location on OR234 - Gold Hill Spur (Hwy #486). Between 2015 & 2018 there were 6 injury A crashes at these intersections. Two of these locations (OR234 @ MP 10.7 & 12.6) is a historic top 5% SPIS site. These three intersection locations have also been a notable crash locations within District 8 for many years.

#### Potential Solutions (Program Manager/Project Sponsor)

DESCRIBE

This project proposes to install the following:

1) Increase sight distance, install lighting, enhance signing, and provide actuated flashing beacons at OR234 & Table Rock Rd. (MP 10.7).

2) Install enhanced signing and provide actuated flashing beacons at OR234 & Antioch Rd. (MP 12.6).

3) Increase sight distance and install lighting at OR234 & I-5 (I-5 @ MP 40.9).

Project Outcomes, Goals and Priorities (Program Manager/Project Sponsor) DESCRIBE

The goal of this project is to reduce crashes at the three un-signalized intersections. This project will accomplish this by a combination of improving sight, adding lighting, improving signing, and adding actuated beacons the these locations.

Constraints and Risks (Program Manager/Project Sponsor)

DESCRIBE

Constraints and risks associated with this project include potential utility conflicts and access to electrical power for installation of lighting at select locations. Aside from these risk, it is assumed that this project will occur entirely within the public right-of-way; although an IGA with Jackson County may be required in order to install safety features on county right-of-way.
